

## CHUCK E. CHEESE 2020 EVERY KID IS A WINNER™ GAME

### OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING. MANY WILL ENTER, FEW WILL WIN A GRAND PRIZE.**

The Chuck E. Cheese 2020 Every Kid Is A Winner Game ("Game") is sponsored by CEC Entertainment Concepts, L.P. ("Sponsor"), 1707 Market Place Blvd., Suite 200, Irving, TX 75063.

- 1. GAME TIMING:** The Game starts on November 16, 2020 and ends on January 3, 2021 but is only available while Game Piece (defined below) supplies last ("Game Period"). Game Pieces must be redeemed by an adult in-store or online, as indicated on the Game Piece and further described in Section 5 of these Official Rules, between November 16, 2020 and January 3, 2021. Game Pieces eligible to be redeemed in-store must be presented for redemption by the accompanying adult (if the winner is a minor) by close of business on January 3, 2021. Grand Prize Game Pieces redeemed online must be claimed by 11:59:59 PM Central Time ("CT") on January 3, 2021 by a participant who has reached the age of majority in his/her jurisdiction of residence, or, if a minor child, his/her parent/legal guardian. Game Pieces presented for redemption after close of business in-store or 11:59:59 PM CT online on January 3, 2021 will be invalid. **Note: Due to on-going COVID-19 pandemic, some stores may be closed during part of the Game Period. If a store closes or adjust services due to local, state, or federal law, rules, regulation, or mandate, that store may allow Game Piece redemptions after January 3, 2021 in the Sponsor's sole and absolute discretion.** Notice will be posted in-store and at <http://chuckecheese.prizelogic.com/rules> ("Website").
- 2. ELIGIBILITY:** The Game is offered only to legal residents of the fifty (50) United States, the District of Columbia, and Canada (excluding Quebec). Grand Prizes must be claimed by a participant who has reached the age of majority in his/her jurisdiction of residence, or, if a minor child, his/her parent/legal guardian. All other prizes must be claimed in-store by the accompanying adult, if the participant is a minor child. **Eligible entrants who are Florida residents are only eligible to play and win at participating Chuck E. Cheese Florida locations.** Employees of Sponsor, the independent third party agency responsible for the administration of this Game ("Administrator"), and their respective affiliates, advertising, promotion and production agencies, and all other individuals and entities associated with the creation, administration or fulfillment of the Game (collectively, the "Game Entities") and such employees' immediate family members (*i.e.*, spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Game. Void in Puerto Rico, all United States Territories and Possessions and overseas military installations, Quebec, and elsewhere where prohibited or restricted by law. All applicable federal, state, provincial, territorial, and local laws and regulations apply and regulations apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Game. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. All redeemed Game Pieces become the sole and exclusive property of the Sponsor and receipt of such Game Pieces will not be acknowledged or returned. For purposes of the Game, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of Game Piece redemption. Entrants will not be allowed to change their physical address or e-mail address.

- 3. HOW TO OBTAIN A GAME PIECE AND PLAY THE GAME:** During the Game Period, an entrant may obtain a "Game Piece", while supplies last, from a participating Chuck E. Cheese location. Minors must be accompanied by an adult. An entrant must peel off the backing of the Game Piece to reveal a win/lose message.

If the Game Piece reveals a winning message, as determined by Sponsor in its sole and absolute discretion, the entrant is the potential winner of the prize indicated on the Game Piece, subject to verification of eligibility, validity of the Game Piece, and compliance with these Official Rules. Game Pieces must be redeemed either in-store or online (as indicated on the Game Piece, and as further described in Section 5 of these Official Rules) by January 3, 2021. Any Game Piece that is presented for redemption after close of business (for in-store redemption) or 11:59:59 PM CT (for online redemption) on January 3, 2021 are invalid.

Limit one (1) Game Piece per person, per calendar day during the Game Period. Mechanical reproductions or Game Pieces obtained outside of authorized channels are not valid. Game Pieces are void if they contain any printing, mechanical, seeding, typographical or other errors, if they have been tampered with or obtained other than through authorized channels or if they are not presented for redemption by January 3, 2021.

If an entrant attempts to obtain more than one (1) Game Piece per day, such Game Piece may, at the Sponsor's sole discretion, be disqualified.

- 4. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:** There are approximately 2,157,715 total Game Pieces available during the entire Game Period. Prizes are randomly seeded across the entire universe of Game Pieces, except as otherwise described below for the state of Florida.

- A. Grand Prizes (2):** Each grand prize is the winner's choice of one (1) arcade game. The dimensions and game descriptions of each arcade game will be made available to the Grand Prize winners to assist in their selections at the time of winner verification. Two (2) Grand Prizes are available during the entire Game Period. The ARV of each Grand Prize is up to \$5,893.40 USD/\$7,846.25 CAD, but depends on the arcade game selected by Grand Prize winner. Any difference between listed ARV and actual value will not be awarded. Odds of winning a Grand Prize is 1:1,078,858. The ARV of each First Prize is \$4.63 USD/ \$5.48 CAD. Odds of winning a First Prize is 1:5. First Prizes must be claimed in-store by an adult.
- C. Second Prizes (215,771 total; 25,200 available in Florida):** Each second prize is a free regular-sized cotton candy (“Second Prize”). 215,771 Second Prizes are available in the Game, with 25,200 available in Florida. The ARV of each Second Prize is \$3 USD/ \$4 CAD. Odds of winning a Second Prize is 1:10. Second Prizes must be claimed in-store by an adult.
- D. Third Prizes (431,543 total; 50,400 available in Florida):** Each third prize is a rechargeable Play Band (“Third Prize”). Third Prize is awarded as a collectible cup for token-only/Franchise locations (see Section 14 for a complete list of token-only locations). 431,543 Third Prizes are available in the Game, with 50,400 available in Florida. The ARV of each Third Prize is \$2.99 USD/\$3.99 CAD. Odds of winning a Third Prize is 1:5. Third Prizes must be claimed in-store by an adult.
- E. Fourth Prizes (215,771 total; 25,200 available in Florida):** Each fourth prize is one (1) ice cream vending item of winner’s choice (“Fourth Prize”). Fourth Prize is awarded as a comparable ice cream option at token-only/Franchise locations (see Section 14 for a complete list of token-only locations 215,771 Fourth Prizes are available in the Game, with 25,200 available in Florida. The ARV of each Fourth Prize is \$2.19 USD/ \$3.25 CAD. Odds of winning a Fourth Prize is 1:10. Fourth Prizes must be claimed in-store by an adult.
- F. Fifth Prizes (215,771 total; 25,200 available in Florida):** Each fifth prize is five (5) Play Points (“Fifth Prize”). Fifth Prize is awarded as five (5) Tokens for token-only/Franchise locations. Play Points/Tokens may be redeemed in-store to play games. Play Points/Tokens have no cash value, may not be redeemed for cash, and are subject to restrictions available in-store. 215,771 Fifth Prizes are available in the Game, with 25,200 available in Florida. The ARV of each Fifth Prize is \$1.65 USD/\$1.65 CAD. Odds of winning a Fifth Prize is 1:10. Fifth Prizes must be claimed in-store by an adult.
- G. Sixth Prizes (431,543 total; 50,400 available in Florida):** Each sixth prize is fifty (50) Chuck E. Cheese game eTickets (“Sixth Prize”). Sixth Prize is awarded as a paper voucher redeemable for fifty (50) Tickets for token-only/franchise locations. 431,543 Sixth Prizes are available in the Game, with 50,400 available in Florida. The ARV of each Sixth Prize is \$0.50 USD/\$0.50 CAD. Odds of winning a Sixth Prize is 1:5. Sixth Prizes must be claimed in-store by an adult.
- H. Seventh Prizes (215,771 total; 25,200 available in Florida):** Each seventh prize is twenty-five (25) Chuck E. Cheese game eTickets (“Seventh Prize”). Seventh Prize is awarded as a paper voucher redeemable for twenty-five (25) Tickets for token-only/franchise locations. 215,771 Seventh Prizes are available in the Game, with 25,200 available in Florida. The ARV of each Seventh Prize is \$0.25 USD/\$0.25 CAD. Odds of winning a Seventh Prize is 1:10. Seventh Prizes must be claimed in-store by an adult.
- I. Total ARV:** The total ARV of all prizes available during the entire Game Period is \$5,045,730.53 USD/\$6,292,478.74 CAD. The total ARV of all prizes available in Florida is up to \$599,702.80.
- J. General Conditions:** An entrant (or, if a minor child, his/her parent/legal guardian) or household cannot win more than one (1) Grand Prize. Sponsor’s decisions will be final and binding regarding

all prize elements. All prizes will be awarded as long as there are a sufficient number of eligible prize claims. All prize details are at the sole discretion of the Sponsor. In the event that, due to technical, typographical, mechanical or other errors, there are more

winners than are stated in these Official Rules, a random drawing among the claimants will be held to determine the winners. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("AAA RULES"). THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN TEXAS. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN DALLAS COUNTY, TEXAS. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR GAME ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR FROM THE END OF THE GAME PERIOD, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.**
